




Those words were written by a young patient who discussed her recent experience at the Community Health Free Clinic. She is one of thousands of uninsured and underserved Eastern Iowans who received free prescription services, medical, dental and vision care from us last year.

In 2023, the Clinic faced a new set of challenges. The continuous enrollment provision of Medicaid, which was increased at the start of the pandemic, was unwound. This left many Iowans without health insurance and turning to us for their health care needs.

Through the years, we have provided these health care services free of charge:

Our Clinic Community

Lawrencia Rogers

Several years ago, Lawrencia Rogers was a Cedar Rapids college student who didn't have health insurance. She also had Type 1 Diabetes and desperately needed assistance with supplies and medication.

But diabetes supplies, like insulin pumps, are extremely expensive. Lawrencia said she couldn't afford to manage diabetes on her own.

"The Community Health Free Clinic helped me adjust back to using syringes," said Lawrencia. "The Clinic supplied me with multiple types of insulin, a glucose monitor, testing strips and syringes. They met every need I had and did so until I was able to become insured again, over a year later."

Today, Lawrencia is healthy, employed and especially grateful for the Clinic's past help.

"The Clinic's assistance meant the world to me," she said. "Untreated diabetes is literally a matter of life or death. I sincerely don't know how I would have afforded medication without their help.

St. Joseph's Catholic School second grade teacher Barb Sullivan says the Marion school tries to incorporate giving in all that they do.

"We always look for ways to give our time, talent and treasure," she said.

It's the reason Mrs. Sullivan's second grade class chose to raise money for the Community Health Free Clinic in the Fall of 2023.

"The students chose the Clinic because each of them has been sick," said Mrs. Sullivan. "They understand the important work that doctors and nurses do, and how expensive medication can be."

She said the first Friday of each month is known as the "Day of Giving." When students arrive at school on this day, they bring money they've earned by doing extra tasks around the house. The money is collected in the main office and each class is responsible for choosing a recipient.

"The students thought it was pretty cool there was a place to go if people couldn't afford health care," said Mrs. Sullivan. "They want to help others."

The Clinic is very grateful and thinks these young donors are pretty cool, too!

Our Community Partners

Free Prostate Cancer Screening Event

In September of 2023, the Community Health Free Clinic hosted a Free Prostate Cancer Screening Clinic. The event was held in conjunction with Mercy Medical Center, First Light Christian Fellowship and Project Health.

Melissa Dean, Director of Health Equity & Community Partnerships at Mercy Medical Center, said forty-three men were screened during the event and/or attended an educational session with Urologist Dr. Matthew Ferroni.

Volunteer Betty Johnson, who recruited community members to take part, said, "We have all collaborated for many years to address the health disparities of our underserved population. I loved the positive spirit and energy among the organizers and attendees."



Menstrual Product Drive

Seventh grader Briley Sellnau of Regis Middle School in Cedar Rapids chose the Community Health Free Clinic as the recipient of her service project in 2023. Her goal was to distribute feminine care products to female patients in need.

Briley gathered donations at her home and, with the help of her Mom, delivered them to the Clinic.

"It's estimated that 14% of women can't afford monthly menstrual supplies," said Briley. "I just wanted to do my part to help."



ARC Award for Clinic Workers

The Community Health Free Clinic was presented with an award from The Arc of East Central Iowa last summer as an outstanding non-profit in the employment field.

Arc Employment Specialist Tora Phelps says the Clinic was among the first local organizations to hire citizens with a disability.

The award was presented by Phelps to Clinic CEO Darlene Schmidt at The Arc's 70th Anniversary Open House in August.



Community Food Partners Help Feed Clinic Patients

The Community Health Free Clinic is fortunate to have two community partners who help feed our patients.

For the past two years, the HACAP (Hawkeye Area Community Action Program) Food Reservoir has delivered food boxes to Clinic patients who indicate a need during registration. The deliveries are based on HACAP's grant availability. HACAP says their goal is to help alleviate food insecurity by providing immediate access to quality foods.

Feed Iowa First, which happens to be one of our neighbors, started dropping off fresh produce bins when they had excess in their gardens. Their donations vary, depending on the season of the year and the abundance of their crops.

The Clinic is grateful to both these organizations for helping us care for those in our community who need it most.





Founded in 2002, Community Health Free Clinic (CHFC) provides free medical, dental, vision and prescription services for community members without access to or the ability to pay for healthcare.

The ability to deliver compassionate care to all those in need — and to do so with respect, collaboration, stewardship, and education — guides the Clinic's processes and programs. The Clinic is funded through the generosity of individuals, foundations, corporations, churches, and grants.

Cardiology, dental, family medicine, general care, in-house medication, internal medicine, optical, orthopedics, patient assistance programs, physical therapy, podiatry, prescription services, pulmonology, and the Senior Health Insurance Information Program are all services provided at the Clinic.

678 dental services were provided in fiscal year 2023




